

DENR ADMINISTRATIVE ORDER

SUBJECT : REVISING THE RATES OF FEES AND CHARGES FOR THE NINOY AQUINO PARKS & WILDLIFE CENTER (NAPWC) AND HINULUGAN TAKTAK PROTECTED LANDSCAPE (HTPL)

Pursuant to Republic Act No. 7586 and Executive Order Nos. 218 and 159, DENR Administrative Order No. 47, Series of 1993 entitled "Revised Rates of Fees for the Entrance to and Use of Facilities inside Protected Areas", is hereby further revised.

Section 1. Scope - The fees and charges herein specified shall apply for the use of facilities and amenities inside NAPWC and HTPL only.

Section 2. Entrance Fees - The fees to be imposed upon entry to the NAPWC and HTPL are as follows:

2.1	Children and students	P 10.00
2.2	Adults	P 15.00
2.3	Sr. Citizens	P 12.00
2.4	Differently-abled persons	free

Section 3. Facilities and Amenities - For the use of facilities and amenities and other activities, the fees and charges are as follows:

Section 4. Mode of Collection

The following procedure shall be observed in the collection of fees and charges;

- 4.1 For entry to NAPWC and HTPL and for the use of swimming pool, the Special Collecting Officer shall issue ticket to the visitors and shall collect and account for the revenues.

- 4.2 For the use of facilities and amenities within NAPWC and HTPL, permit shall be issued by the Park Superintendent or his authorized representative upon reservation. The permit shall be presented to the cashier or the duly designated Special Collecting Officer for the corresponding Order of Payment and Official Receipt for such payment shall be made.
- 4.3 Payment of fees shall be made on cash basis only.
- 4.4 The Bureau shall account and remit the above-mentioned fees to any authorized Government Bank as trust fund on IPAF.

Section 5. Repealing Clause

All other provisions of DAO 47, Series of 1993 shall remain in force. Other issuances inconsistent herewith are hereby superceded or amended.

Section 6. Effectivity

This Order shall take effect fifteen (15) days after its publication in a newspaper of general circulation.
